Annual Renewal Fee Change

The annual renewal fee for Diplomates in 2007 has increased to \$100. The last fee increase occurred six years ago in 2001. Initial statements were mailed the first week of October. Second reminders will be emailed the end of November.

CAIH No Longer Offered

The Board voted in July to no longer offer the Certified Associate Industrial Hygienist (CAIH) examination. Those who have achieved the CAIH can continue to maintain their certification. Current CAIHs and CAIH applicants who meet the recently revised CIH requirements will be eligible to sit for the CIH examination.
